NISGA'A LANDS DESIGNATION ACT

Designation of Nisga'a Village Lands

1. The Nisga'a Lands described
 - (a) in Schedule A are designated as the Nisga'a Village Lands of the Nisga'a Village of New Aiyansh,
 - (b) in Schedule B are designated as the Nisga'a Village Lands of the Nisga'a Village of Gitwinksihlkw,
 - (c) in Schedule C are designated as the Nisga'a Village Lands of the Nisga'a Village of Laxgalt'sap, and
 - (d) in Schedule D are designated as the Nisga'a Village Lands of the Nisga'a Village of Gingolx.

Designation of Nisga'a Private Lands

2. The executive may, by regulation, designate any Nisga'a Public Lands as Nisga'a Private Lands.

Schedule A
Nisga'a Village Lands of the Nisga'a Village of New Aiyansh
