If you meet the Nisga'a eligibility criteria and you are currently enrolled in another land claims agreement in Canada, you may be conditionally listed on the Nisga'a Enrolment Register. However, your enrolment will not become effective until you cease to be enrolled in the other land claims agreement. If the Enrolment Committee gives you written notice of your conditional enrolment in the Nisga'a enrolment register, you will have **60 days** to demonstrate that you have ceased to be enrolled under the other land claims agreement.
